#### Fernleigh Station Lane, Witney

Fernleigh is a luxurious extra care development of 80 one and two bedroom apartments – with 10 for shared ownership, 38 for sale and 32 for rent.

Close to Witney town centre, Fernleigh provides easy access to a wide range of shops and leisure facilities, along with excellent transport links.

Fernleigh benefits from:

# **EXTRA CARE HOUSING - ELIGIBILITY CRITERIA**

#### Rented and shared ownership accommodation

To be eligible to apply for a rented or shared ownership apartment at either of these schemes you would usually be expected to be aged 55 or over (for couples, one of you should normally be 55 or over).

However, all cases are looked at individually by an allocations panel and exceptions may be made where it is felt that applicant(s) a little younger than 55 would benefit from living in extra care accommodation. Preference will usually be given to applicants with some level of assessed care need.

## Local connection

At Fernleigh, preference will be given to applicants with a local connection to West Oxfordshire.

- A local connection to West Oxfordshire is established where an applicant:
- is normally resident in the district in permanent accommodation; or
- has previously lived in the district for three out of the five years prior to the date of application or has been previously resident in the district for at least 10 years in total; or
- is employed in the district or has a written offer of permanent employment (self-employed applicants should be primarily working in the district or have their business based in the district); or
- has family resident in the district i.e. parent, children, grandchildren, or sibling (including step, in-law and foster relatives). Family residents should have lived in the district for at least five years in total; or
- is a former member of the armed forces (including if the applicant is a former spouse of a member of the armed forces who lived with them whilst they were a serving member); or
- is a person to whom the district council has a duty to secure accommodation under homelessness legislation; or
- is a person whose application should be accorded reasonable preference under partVI of the Housing Act 1996 on medical or welfare grounds (as determined by the district council).

At The Paddocks preference will be given to applicants with a local connection to: Milton-under-Wychwood, Ascottunder-Wychwood, Shipton-under-Wychwood, Cornbury and Wychwood; then to applicants with a local connection to the associated parishes of Bruern, Chadlington, Churchill, Fifield, Idbury, Fulbrook, Lyneham, Leafield, Kingham, Sarsden, Swinbrook, Taynton and Widford; then to applicants with a local connection to West Oxfordshire.

A local connection in regard to The Paddocks is established where the applicant:

- has lived in the areas listed above for a continuous period of at least 12 months preceding the date of the offer of accommodation; or
- is permanently employed within these areas and has been for at least 12 months; or
- · has previously lived in these areas for a period of at least three years; or
- has close relatives who have been living in the areas for at least three years. Close relatives are defined as parents, children, siblings, grandparents or grandchildren (including step relatives).

Applicants without a local connection as outlined above may still be considered by the allocations panel, but will not have preference.

Please note, the sales apartments at Fernleigh are not subject to the eligibility criteria listed above.
